Patent law is the branch of intellectual property law that deals with new inventions. Traditional patents protect tangible scientific inventions such as engines, machinery, mobile phones. However, over the years, patents have been granted to biological inventions such as isolated genetic sequences. Once granted, a patent gives the inventors the exclusive right to use/sell/distribute their invention for 20 years.

**Copyright law** gives the creators of literary, dramatic, musical, artistic works, sound recordings, broadcasts, films and typographical arrangement of published editions, rights to control the ways in which their material may be used. Copyright in artistic works generally lasts for the lifetime of the artist plus 70 years after their death

Trademark law is set up to protect trademarks. A trademark is a legal protection given to any word, name, symbol, or design that is used in commerce to identify the product of one manufacturer from another. In the business world, a trade mark provides a product or organisation with an identity which cannot be imitated by its competitors. For instance, COCA-COLA is a trademark of Coca Cola Company.

#### 1. Patent Attorney


